## **NCCPD Warns Residents of "Distraction Burglaries"**

The New Castle County Police are currently investigating two distraction burglaries that occurred Monday (02/02), during the afternoon hours, in the community of Langollen Estates and the Richardson Park area. A distraction burglary occurs when an unsolicited visitor or salesman comes to your home and offers to do home improvements, or to alert you of a problem at your home.

On February 2, 2015, New Castle County Patrol Officers responded to the communities of Langollen Estates and the Richardson Park area in reference to a reported distraction burglary. Both elderly victims reported that they were approached by a white male who spoke to them about an issue on their property. The issue involved getting the victims out of the residence to speak about the issue. One of the victims observed another white male inside the home upon going back inside to retrieve some paperwork pertinent to the issue raised.

Some of the most common scams are to pave driveways, seal roofs, trim trees, fence repairs, or paint houses with materials that wash off in days or weeks. They will also act as utility workers or other service employees as a ruse to gain access to your residence. In some cases the scammers will lure the homeowner outside of the residence to show them the problem that needs to be corrected. While distracted outside the residence, an accomplice who is unseen by the victim, will enter the home and steal cash, jewelry, or electronics.

If you have been victimized, or the victim of an attempted scam, please call the New Castle County Police at 911 immediately. Descriptions of suspects and the vehicles they are operating are very helpful to detectives as they investigate these crimes.

Follow these helpful tips that can help you from becoming a victim:

- If you're not sure who the person is behind your door, don't open it!
- If you are successfully lured outside of your home, make sure to lock the door behind you. Most importantly, make sure all entryways leading into your home are locked as well. This includes doors, windows, and the garage.
- If the "con" is so convincing, call a neighbor or friend nearby to come along and check the perimeter of your home, or check on the visitor before opening your door.
- If the deal sounds too good to be true it probably is.
- Any person who solicits door-to-door sales to a residential home in the State of Delaware is now required to display a Salesperson Identification Card (ID card). To verify that the Salesperson ID Card is not a forgery, the names of all Salesperson ID Card holders will be available on the Division of Revenue website at www.revenue.delaware.gov.

We advise all residents to request proper identification from these individuals before letting them into your home. As always, residents are encouraged to report any suspicious vehicles and persons to the police immediately by calling 9-1-1.
